

2020 No. 24 Announcement from CMRA

The Qualification Accreditation of Overseas Suppliers and Domestic Consignees of Recycling Copper and Aluminium Raw Materials

In order to ensure the quality of raw materials, strengthen industry self-discipline, and promote the high-quality development of China's recycling nonferrous metals industry, China Nonferrous Metals Industry Association Recycling Metal Branch (hereinafter referred to as: CMRA) intends to cooperate with third-party professional organizations to develop Qualification Accreditation by Overseas Suppliers and Domestic Consignees of Recycling Copper and Aluminium Raw Materials (hereinafter referred to as qualification accreditation). The relevant information as follows:

I. Organization

Guided by General Administration of Customs

Organization and implementation: China Nonferrous Metals Industry Association Recycling Metal Branch (CMRA)

II. Accreditation Method

1. Qualification accreditation enterprises apply for voluntary and free.
2. Qualification accreditation is carried out by a combination of written review and site inspection.

III. Accreditation Procedure

CMRA has established the "Qualification Accreditation Office for Overseas Suppliers and Domestic Consignees of Recycling Copper and Aluminum Raw Materials" (hereinafter referred to as the Qualification Accreditation Office) as a daily office responsible for the daily management and coordination of qualification accreditation. Establish a qualification accreditation Expert Review Committee (hereinafter referred to as the Review Committee) to be responsible for the review of materials, site and accreditation results.

1. After the Qualification Accreditation Office conducts a preliminary review of the completeness and consistency of the application materials, it shall coordinate and organize the Review Committee to conduct the review.
2. In accordance with the relevant provisions of the "Administrative Measures for Qualification Accreditation" (Attachment 1 of the announcement), the Review Committee conducts material review and site inspection of the application materials of enterprise, and signs opinions.
3. The Qualification Accreditation Office publicizes the preliminary accreditation results on the official website and official microblog of CMRA based on the opinions of the Review Committee.
4. After the announcement, CMRA will issue a qualification certificate and report to the General Administration of Customs for the record.
5. During the publicity period, if there are any objections to the preliminary accreditation result, the Qualification Accreditation Office will organize

verification.

IV. Material acceptance

1. How to submit materials. According to the requirements of the announcement (Attachment 1), the applicants will bind the application form and the paper version of the materials into a book in duplicate and express it to the Qualification Accreditation Office (Address: CMRA, Floor 3, Chuangjing Building, 38 Shouti South Road, Haidian District, Beijing, postcode: 100037), indicating "Qualification Accreditation Document"; and an electronic version is sent to the chinacmra@gmail.com. Intending participating companies can contact Qualification Accreditation Office to obtain the application form.
2. Deadline. Within 20 working days for the date of issuance of this announcement (subject to the delivery time of the express)
